Self Employment Model Details



Our self-employment service is based on a German model, called the Unmanaged Model, and it costs around 40% less than the standard, 'agency managed' model widely promoted in the United Kingdom. The standard UK rate varies between £1,000 and £1,200 a week. Our prices start from £623 a week – please see our pricing page for more information. We handle all employment duties for you and your carer, so you can relax and live your life. £623-777 is your final weekly price!

Principles of the Unmanaged Model:

- Carer duties are not subject to agency supervision, direction or control. The relationship between the client and carer will be set in contract for services.
- The carer will be employed on self-employed basis. Veritas Care will manage all registration and administration services.
- The carer is free to work with their choice of client and for more than one client.
- The carer is trained by us to the highest standard at Academy of Care, run by our sister company. All of our carers are fully competent to carry out their tasks.
- If you are not happy with the carer provided

by us, we will provide a replacement, free of charge.

- All carers work on rotational basis. If you require long-term care, only two carers will be involved in your care, providing continuity and consistency in care.
- Your contract with your carer is continuous with a 2 week term of notice by either party.
- All carers have DBS certificates and certificates of no-criminal convictions from local courts.
- Your requirements will be assessed by a qualified and experienced team.
- Our coordinators will provide full support during your engagement with your carer.

When is live-in care useful?

Live-in care means that you can stay in your own home, rather than moving to a residential home.

You can stay with your family, pets, garden, and close to friends and neighbours. You can do what you want, when you want to.

Long term live-in care is an economical alternative to residential care, with the comfort of being in your own home.

It's a 24/7, one-to-one service, shaped by each individual client's situation and needs, supporting their independence and enabling daily freedom of choice.

A major benefit of our service is the constant care and companionship you receive at home from a carer who is dedicated to your needs.

Many clients need someone who will stay in the house almost all day so that they can live at home independently and safely.

Most of our clients have live-in carers for years, staying as independent as possible, for as long as possible.

Continuity of care creates familiarity and helps develop comfortable routines; it builds a relationship between customer and carer which is based on mutual trust. Our experience has taught us that continuity of care is extremely important.

We aim to have our carers stay in the home for several weeks at a time; they then take a break before returning. During the rest period cover is provided.

We guarantee cover for our clients so they will never be left alone. If you have any problems or concerns, you can change a carer at any time, simply by contacting our office. We will talk through the reasons for your decision; understand your concerns and endeavour to introduce another care worker that will suit you better.

HOW DOES IT WORK?

We've developed our service to make the process from initial enquiry to the arrival of your carer as smooth as possible.

1. Information gathering

- Call us or complete our contact or care assessment form and we will call you back when it suits you.
- We have an initial telephone interview with our client or their representative. We know from experience that the best first step is to have a conversation about your specific situation.
- We ask you to complete our online Care Assessment form to gather as much information as possible about a prospective client and their needs. This is a no-obligation, free-of-charge process during which our experienced team will offer advice and source information to assess risks, provide you with a quotation and, most importantly, to find the best carer match for you. We are also available to assist you to complete the form over the phone and to discuss any queries you may have.


2. Individual costs - Once we have an idea of your requirements we'll provide a final costing to you.

3. The full recruitment process includes:

- Receiving candidate's CV through Veritas' nationwide recruitment campaign.
- An initial interview with the candidate to assess experience, education, level of English and carry out a suitability check.
- Collection and verification of all necessary documentation and information required for DBS.
- Contacting previous employers - verbal references, employment background check.
- Obtaining local DBS certificate - a no-criminal conviction certificate provided by local courts.
- Second interview, face-to-face or via Skype.
- Obtaining written references from previous employers covering specified minimum period.
- Final interview and client's approval of the candidate.

4. Placement of carer.

As soon as you confirm you wish to proceed, we put you in touch with a suitable carer. When you have spoken to the carer and the placement has been agreed, we will make travel arrangements and let you know the date and time of their arrival.

Choosing right candidate

You can choose your own carer! You will be requested to complete our enquiry form with details that will allow us to match the best candidate for your needs. We will send the carer's detailed profile for your review and then, if you are happy with all the criteria, we will organise an interview in person or via Skype. In any case, you can be assured that you will be provided with all the information you need prior to meeting the carer for the first time, so that you have a clear idea of their personality and skills.

Candidate screening

It is extremely important that every carer is carefully selected and has gone through an enhanced, comprehensive screening process. Our screening process is very extensive and strict and includes:

- Verifying experience in live-in care and ensuring a passion for delivering good quality care - this means obtaining and checking recent professional and personal references.
- Identification check.
- Applying for enhanced DBS check and obtaining a police check from the carer's country of residence, if applicable.
- An interview to assess levels of written and spoken English and the carer's personality and hobbies.
- Obtaining evidence of recent training



from professional bodies.

- Assessing interpersonal skills.
- Psychometric tests help to identify a candidate's skills, knowledge and personality. These used during the preliminary screening stage. We are looking for the following character traits: a sense of humour, good listening skills, a caring nature, etc. We implement psychometric testing to select only candidates with the highest standards of these skills.

ARE CARERS INSURED?

There is no statutory requirement for a self-employed carer to have Public Liability or Professional Indemnity insurance. We recommend all carers are insured but ultimately, this at the client's discretion. Veritas Care will ensure all carers have a valid insurance policy in place if this is requested by a client.

HOW DO I PAY MY CARER? DO I HAVE TO PAY UPFRONT?

Typically care services are paid on weekly basis, but if you request to change your payment plan we can amend it to your needs. Weekly payments are paid by bank transfer or direct debit. You never pay upfront for care services.

IS THERE A MINIMUM CONTRACT LENGTH?

We are flexible about how long your carer stays with you. The length of stay is usually based on the individual requirements of our clients. This will be agreed between you and your carer. We recommend minimum stay of 6 weeks and you can arrange for a long term stay, up to 12 months, if required. In rare



cases, if the client does not feel the match is right, we can make arrangements to replace your carer. When placing a carer, we always take into account our clients' preferences in relation to our carer's character, religion and cultural beliefs.

ARE YOU CQC REGULATED?

We operate as a private job placement agency and therefore, fall outside the scope of the Health and Social Care Act 2008. This means we are not regulated by the Care Quality Commission (CQC). We have provided live-in care to over 17,000 customers in Germany Austria, Switzerland, Ireland and UK, and this unique experience in the field is our best qualification.

WHAT RECRUITMENT CHECKS DO YOU PROVIDE?

A lot! Our screening process is very extensive and strict. We obtain and verify recent professional and personal references, carry out identification checks, apply for an enhanced criminal record check through the DBS (Disclosure & Barring Service) in the UK and obtain a police check from the carer's country of residence where applicable. We conduct interviews to assess written & spoken English, personality and hobbies. We collect evidence of recent training by professional bodies and we consider candidate's work experience. We also undertake personality analyses and psychometric tests. Our commitment to reliability

and our specialist expertise and experience means we will not let you down.

WHERE DO YOUR CARERS COME FROM?

Our carers come primarily from Poland and Central Europe. All of our carers have good spoken and written English, and great communication skills as well as extensive experience in live-in care. Our carers gained their experience mainly in Germany, where full-time live-in care is the most popular kind of care.

DO WE HAVE TO PAY EXTRA FOR THE CARER'S TRAVEL?

A one-off payment of £80 is required towards travel and is payable to the carer at the end of the contract. The fee does not apply when the contract between the client and carer is ended early by the carer.

ARE THE CARERS INTRODUCED BY VERITAS CARE EMPLOYED OR SELF-EMPLOYED?

Carers introduced by Veritas Care are self-employed. This has some great benefits all-round: the carers are engaged to work for a duration of time that suits both of you and the carer is responsible for their own tax and National Insurance contributions.

WHAT AREAS DO YOU COVER?

We can introduce a carer anywhere in the UK.

WHEN DOES MY CARER ARRIVE?

We need around 5 working days to organise the carer's arrival to your home. The exact date and time will be agreed between you and your carer.


CAN I CANCEL A CONTRACT?

You can cancel a contract at any time. The initial two weeks of the contract are treated as a probationary period when either party can cancel at any time. After this period, the standard two weeks' notice applies.

DO I NEED TO PAY EMPLOYERS NATIONAL INSURANCE?

No, our carers work on a self-employed basis and there is no statutory requirement to pay Employers NI.
